Please note:

*** The final warm-up session ends at 7:50. The Championship Pool must be cleared at that time. **NO DIVING is allowed in lane 9 of the south 6-lane pool.**

*** Lanes 9-14 (located in the south 6-lane pool) will NOT BE OPEN after the start of the meet. No meet participants will be allowed in or around the south 6-lane pool once the meet begins.

*** The Stonegate pool complex has a new public entry in the new Community Center at the southern end of the complex. During Finals the new public entry will be open for use by Stonegate residents that are NOT participating in the Finals meet. No meet participants will be allowed to enter the pool complex by that entryway. Meet participants should enter the competition pool area by gates in the west, north and east sides of the pool fencing as has been done in the past at the Championship Finals meet.

- 8:00 am** Start of Meet (Event 1, Consolation Heat)

TENTS:

Teams may set up their tents in the designated areas of the park to the north and east of the pool. Each team will find a stake designating their assigned tent location. Tents may be dropped off in the designated unloading area along Stonegate Parkway, directly north of the Stonegate Activities Center. **NO VEHICLES WILL BE ALLOWED IN THE PARK!** A trash bag will be attached to each team's tent marking stake. Please police your tent area after the meet. **DO NOT USE METAL TENT STAKES. ASIDE FROM THOSE ASSOCIATED WITH MEET OPERATIONS, NO CANOPIES MAY BE SET UP ON THE POOL DECK.**

BLEACHERS:

There will be several bleachers available for viewing events. Please be courteous of other spectators and only sit in the bleachers for the event(s) you wish to see. Please do not "mark" your spot on the bleachers or sit on the bleachers the entire meet.

PARKING:

Parking for the meet is available in the pool parking lot and along the streets around Stonegate Park. Parking will be limited to the northern part of the pool parking lot. The south part of the pool parking lot will be reserved for use by other Stonegate residents, so they can use the south 6-lane pool during the meet. Overflow parking is available at Pine Grove Elementary School, one block south of the pool. There are parking lots on both the north and south sides of the school building. Please be considerate of our Stonegate neighbors. There is ample parking around the park and in the school parking lots. Please **DO NOT** park in adjoining neighborhoods. Illegally parked vehicles will be ticketed or towed.

COACHES AREA:

Coaches will have designated areas on the north and south sides of the pool. Tickets for coaches' lunches will be distributed before the meet. Tickets can be redeemed for lunches at the concession area. Refreshments will be available for the coaches in a hospitality area at the northwest corner of the competition pool deck.

CARDS/HEATING:

The heating area is on the east side of the pool and can only be accessed from the park outside the pool area. **ONLY** heating swimmers, coaches, working volunteers, and parent representatives will be allowed in the heating area. All others, including non-heating swimmers and parents, will be asked to leave the heating area.

VOLUNTEERS:

ALL volunteers assigned to work the meet by their teams should check in before the meet at the volunteer check-in table located at the pool entrance. They must confirm their presence and receive a nametag.

BODY ART:

Swimmers are not to have body paint or tattoos that will come off on the pool furniture. Any swimmer with body art **WILL** be asked to remove it before swimming.

RESULTS:

Meet results will be posted in the window on the east wall of the Stonegate Activities Room, which is located just north of the competition pool.

PROGRAMS:

Programs (\$4) and highlighters (\$1) will be available for purchase at the pool entrance.

SOUTH 6-LANE POOL, BABY POOL AND SLIDE POOL GUIDELINES:

The south 6-lane pool, baby pool, and slide pool will NOT be open during the meet. Meet swimmers will be asked to leave that area during the meet, and meet spectators WILL NOT be allowed around the area after the meet begins. These pools will be reserved for the exclusive use of other Stonegate residents that are not participating in or attending the Finals meet.
